#### **CRUISE PARTICIPANT AGREEMENT** "Skinwalker Uncharted" Seminar-at-Sea

#### January 4 to 11, 2026 (7 nights) Miami • St. Maarten • St. Thomas • Nassau, Bahamas • Miami Royal Caribbean Symphony of the Seas

#### **1. DEFINITIONS OF TERMS**

#### 1.1. "Cruise"

Refers to the 7-night seminar-at-sea organized by Susan Shumsky of Divine Travels and Vitaly Ezra'El of Zohar Entertainment Group International (with and on behalf of FAM Networks). The Cruise will take place aboard the Royal Caribbean Symphony of the Seas, sailing January 4–11, 2026, round-trip from Miami to St. Maarten, St. Thomas, Nassau (Bahamas), and returning to Miami.

**1.2. "Cruise Organizers"** refers to Susan Shumsky of Divine Travels, Vitaly Ezra'El of Zohar Entertainment Group International (acting on behalf of FAM Networks), and their official representatives: Luxury Travel Destinations and Royal Caribbean Cruise Line.

**1.3. "Cruise Presenters"** refers to the Investigative Team of Skinwalker Ranch as posted at <u>https//skinwalkeruncharted.com/speakers-workshops</u>

#### 1.4. "Skinwalker Uncharted Shore Excursions"

Refers to exclusive, custom-designed group tours at selected port stops during the Cruise, and also Pre- Cruise and Post-Cruise.

**1.5. "Cruise Registration Form"** is the registration form posted at:

**1.6. "Shore Excursions Registration Form"** refers to the official form that, once available, will be posted at <u>https://skinwalkeruncharted.com/excursions-registration</u>

**1.7. "Cruise Participant"** is a person who has registered for the Cruise on the Cruise Registration Form.

**1.8. "Cruise Participant Agreement"** refers to this legal document, which each Cruise Participant is required to agree to: <u>https://skinwalkeruncharted.com/agreement.pdf</u>

**1.9. "Cruise Itinerary"** refers to the scheduled travel route round-trip from Miami, with stops in St. Maarten, St. Thomas, and Nassau, Bahamas:

**1.10. "Cruise Schedule"** is the tentative schedule of Cruise seminar-at-sea activities posted at <u>https://skinwalkeruncharted.com/full-schedule</u>

**1.11. "Cruise Fee"** is the payment made by Cruise Participant for participation in the Skinwalker Uncharted Cruise seminar-at-sea.

**1.12. "Cruise Sailing"** is the Royal Caribbean Symphony of the Seas ship's scheduled cruise that will occur from January 4 to 11, 2026.

**1.13. "Skinwalker VIP Package" ("**VIP Package") refers to a premium, limited-availability experience offered exclusively to participants of the Cruise, as outlined here: https://skinwalkeruncharted.com/cruise-package

#### **2. CONDITIONS OF BOOKING**

Payment by a Cruise Participant to join the Cruise constitutes full acceptance of the terms and conditions outlined below.

## **3. HOLD HARMLESS**

The Cruise Organizers are responsible for coordinating all arrangements related to the Cruise, including reservations and operations. Participation in the Cruise is subject to the condition that the Cruise Organizers shall not be held liable for any delays, theft, damage, injury, or other irregularities, regardless of cause. Specifically, the Cruise Organizers assume no responsibility or liability for:

- 1. Any changes to or delays in air schedules, missed airline or carrier connections, or other transportation services.
- 2. Injury, loss, or damage to persons or property, including luggage.

- 3. Additional expenses or losses resulting from fluctuations in exchange rates, tariffs, itinerary adjustments, health regulations, or vaccination mandates.
- 4. Defects in any vehicle or the acts or defaults of any company or individual engaged in transporting Cruise Participants or executing arrangements related to the Cruise.
- 5. Expenses incurred due to sudden illness, weather conditions, strikes, war, terrorism, pandemics, quarantine, accidents, or other acts of God.
- 6. Losses arising from cancellations.
- 7. Changes to the Cruise Itinerary or Cruise Schedule.
- 8. Missed port stops, missed Shore Excursions, or financial losses resulting from the Royal Caribbean cruise line's cancellation of docking or tendering at any port for any reason.
- 9. Physical, mental, or emotional injury resulting from participation in the Cruise.
- 10. Disappointment or dissatisfaction experienced by Cruise Participants regarding any aspect of the Cruise.
- 11. Acts or omissions of travel suppliers or their failure to adhere to their own schedules, provide services or refunds, financial default, or failure to honor future trip credits.
- 12. Modifications to the Royal Caribbean cruise line's policies regarding what is or is not included in the fare.

## 4. CHANGES TO ITINERARY OR SCHEDULE

Modifications to the Cruise Itinerary or Shore Excursions are to be anticipated. The Cruise Organizers, Royal Caribbean Cruise Line, and local Shore Excursion providers reserve the right to make any necessary changes, with or without prior notice, in the interest of safety and smooth operation of the Cruise. Such changes shall not entitle Cruise Participants to any refund of the Cruise Fee or Shore Excursion Fees.

## 5. NO GUARANTEES

The Cruise Organizers make no guarantees, stated or implied, regarding any aspect of the Cruise. Complaints or dissatisfaction will not entitle any Cruise Participant to a full or partial refund. Specifically, the Cruise Organizers will not issue refunds based on:

- 1. The number or age of Cruise Participants.
- 2. The fitness or ability of any Cruise Presenter to travel.
- 3. The attendance or non-attendance of any specific Cruise Presenter.
- 4. Whether a specific Cruise Presenter participates in any Shore Excursion.
- 5. Whether a specific Cruise Presenter gives a presentation onboard the ship.
- 6. The amount of time any Cruise Presenter devotes to leading presentations personally.
- 7. Photos posted on the Cruise website or any specific locations mentioned or shown.
- 8. The quality or subjective experience of lectures, workshops, Q&As, panels, or other events.
- 9. The content, advice, or suggestions shared by Cruise Presenters.
- 10. Any ports of call the ship may skip or stop at.
- 11. Shore Excursions that may be canceled or missed for any reason.
- 12. Any other aspect of the Cruise experience.

#### <u>6. RATES</u>

Cruise rates, taxes, port charges, gratuities, and required nonrefundable fees are listed on the Cruise Registration Form. All quoted rates are valid only for the specified time period and are subject to change at any time.

The Cruise Fee becomes fixed once the Cruise Participant's credit or debit card is charged for the reservation fee and their booking on the Cruise Sailing is confirmed.

The Cruise Organizers reserve the right to offer and publish different rates (higher or lower) for other potential Cruise Participants at any time prior to the Cruise. No refunds will be issued due to rate changes.

#### 7. RATES AFTER GROUP ALLOTMENT EXPIRES

Once the Cruise Organizers' reserved group allotment (group stateroom inventory) is no longer available, any additional staterooms for Cruise Participants will be reserved based on Royal Caribbean's current inventory and prevailing rates at the time of registration. Stateroom availability and pricing are subject to change at any time.

All registrations are processed manually. After a Cruise Participant submits the Cruise Registration Form, if Royal Caribbean's rates are higher than those listed on the Registration Form, the Cruise Participant will be contacted by Diane Michael of Luxury Travel Destinations and notified before any charges are made. If the requested stateroom category is available and the new rate is approved by the Cruise Participant, the registration will proceed.

### **8. ROOMMATE MATCHING PROGRAM**

Cruise Participants who wish to register at the double-occupancy rate but do not have a specified roommate may request that the Cruise Organizers attempt to match them with another Cruise Participant. While the Cruise Organizers will make reasonable efforts to find a match, no guarantees can be made.

The Cruise Participant's credit card will not be charged until a suitable roommate has been found and confirmed by the Cruise Participant. If no match is found, the Cruise Participant will be offered the option to upgrade to a single stateroom at the applicable rate.

Any Cruise Participant participating in the Roommate Matching Program must pay the full retail rate quoted on the Cruise Registration Form at the time a match is confirmed. Once a match is accepted, the full Cruise Fee becomes nonrefundable.

If the Cruise Organizers match a Cruise Participant with a roommate who is later deemed unsuitable by the Cruise Participant and a room change is requested, then (if space is available) the Cruise Participant must pay the single-stateroom supplement for both themselves and the originally assigned roommate.

No refunds will be issued for dissatisfaction related to roommate assignments.

## 9. CRUISE FEE PER PERSON INCLUDES

- 1. Cruise Sailing aboard Royal Caribbean Cruise Line in the stateroom category booked by the Cruise Participant.
- 2. Full lodging and meals at all of the complimentary dining venues on the ship.
- 3. Room service for Continental Breakfast only, available from 6:00 AM to 11:00 AM (subject to change).
- 4. Access to all scheduled meetings and workshops listed in the Cruise Schedule (excluding Shore Excursions).
- 5. Use of all complimentary ship amenities, including pools, hot tubs, games (excluding casino), sports facilities, fitness center, free classes, adult and youth activities, and entertainment.
- 6. Port charges and government taxes totaling \$200.10 per person.
- 7. Prepaid gratuities for onboard staff (housekeeping, stewards, waitstaff, etc.) totaling \$129.50 per person.

#### **10. CRUISE FEE PER PERSON DOES NOT INCLUDE**

- 1. Transportation to and from the Cruise Sailing embarkation and debarkation port.
- 2. Any food or room service beyond the complimentary dining venues and complimentary Continental Breakfast room service (6:00 AM to 11:00 AM: subject to change).
- 3. Gratuities for personal services and individual purchases.
- 4. Phone calls made from the ship.
- 5. Internet and Wi-Fi access onboard.
- 6. Bottled water, sodas, and alcoholic beverages.
- 7. Travel, accident, baggage, health, or life insurance.
- 8. All airfares and any increases in airfare.
- 9. Excess baggage fees.
- 10. Expenses related to guides or transportation not included in the Cruise Schedule.
- 11. Private excursions and recreational activities not listed in the Cruise Schedule.
- 12. Spa and salon services.
- 13. Paid fitness classes and consultations.

- 14. Photo Gallery prints taken by the ships' photographers, including the official Skinwalker Uncharted group photo.
- 15. Any other items not specifically mentioned in the Cruise Schedule.

## **11. ONBOARD ACCOUNT**

Each Cruise Participant will be required to establish their own onboard credit account upon boarding the ship. This account will be used to pay for incidentals such as spa treatments, paid fitness classes, Wi-Fi access, bottled water, soda, alcoholic beverages, specialty restaurant charges (outside of complimentary dining), onboard shopping, photo prints (including the official Skinwalker Uncharted group photo, casino expenses, transfers, and ship-to-shore phone calls.

# **12. RESERVATION FEES AND BALANCE DUE**

## **13. CANCELLATION BY CRUISE PARTICIPANT**

If the Cruise Participant cancels their reservation for any reason, **the nonrefundable reservation fee (**\$550 per person for double occupancy or \$800 for single occupancy) will be forfeited. Additional cancellation fees apply as follows:

- After September 30, 2025: 25% of the total Cruise Fee
- After October 15, 2025: 50% of the total Cruise Fee
- After October 29, 2025: 75% of the total Cruise Fee
- After November 28, 2025: 100% of the total Cruise Fee (no refund)

There will be **no refund for Cruise Participants who fail to appear for the Cruise ("no-shows")**, regardless of reason.

Regarding airfare cancellations: Cruise Participants are solely responsible for obtaining any refunds or credits from their airline carrier. Airline tickets may be subject to penalties, surcharges, or may be entirely nonrefundable. Cruise Organizers accept no responsibility or

liability for losses related to airline cancellations. **No refunds** will be issued for any Cruise Participant who departs the Cruise prior to its conclusion, for any reason.

No refunds will be granted to Cruise Participants in the Roommate Matching Program (as stated in Section 8 of this Agreement).

No refunds will be given for canceled or unused Shore Excursion tickets, regardless of reason.

The VIP Package is **non-refundable for any reason**; however, it may be **transferred** to another registered Cruise Participant, subject to approval and facilitation by the Cruise Organizers.

Regarding transfers for Shore Excursions or VIP Packages, the Cruise Organizers **cannot guarantee** the success of any transfer request and shall **not be held liable** if a transfer cannot be completed.

## **14. CANCELLATION BY ORGANIZERS**

The Cruise Organizers reserve the right to cancel the Cruise if there is an insufficient number of Cruise Participants registered. In such a case, Cruise Participants who have paid a deposit or made full payment will receive a refund, excluding any nonrefundable deposits paid to Royal Caribbean Cruise Line.

The Cruise Organizers also reserve the right to cancel any Shore Excursion due to insufficient participation. In such cases, Cruise Participants who have paid for the affected excursion will receive a full refund of that specific Shore Excursion fee.

If the Cruise is canceled by the Cruise Organizers after a Cruise Participant has already canceled their reservation, no refunds, reimbursements, or compensation will be issued to that Cruise Participant.

#### 15. CANCELLATION FOR REASONS BEYOND CRUISE ORGANIZERS' CONTROL

If the Cruise Sailing is fully or partially canceled by Royal Caribbean Cruise Line, or if unexpected events force the Cruise Organizers to cancel the Cruise, or if a Cruise Participant must cancel for the same reasons, the Cruise Organizers are **not responsible** and **will not be held liable** for any losses. Unforeseen causes include, but are not limited to:

- Changes in itinerary.
- Sequestering or isolation orders.
- Severe weather conditions.
- Labor strikes.
- Economic collapse or stock market crash.
- War or terrorism.
- Quarantine or pandemic restrictions.
- Acts of God.
- Unsafe conditions for boarding, sailing, docking, or tendering.
- Any other force majeure events beyond the Cruise Organizers' control.

In such cases, **no refunds or future cruise credits** will be issued by the Cruise Organizers unless such compensation is provided directly by Royal Caribbean Cruise Line.

#### **16. SHORE EXCURSIONS REQUIREMENT**

Skinwalker Uncharted Shore Excursions are exclusively available only to guests who meet one of the following criteria:

- 1. Cruise Participants who have completed the Cruise Registration Form and have paid in full for the Cruise and seminar-at-sea and have booked through Luxury Travel Destinations.
- 2. Individuals who are staying in a stateroom with at least one Cruise Participant who has completed the Cruise Registration Form and has paid in full for the Cruise and seminar-at-sea, and has booked their Cruise through Luxury Travel Destinations.

#### **27. WAIVER**

This Agreement may only be modified through the written consent of both the Cruise Participant and the Cruise Organizers. It represents the entire understanding between the Cruise Participant and the Cruise Organizers regarding the subject matter contained herein. No other contract or agreement, whether stated or implied, exists between the parties on this subject.

The Cruise Organizers' failure to enforce any provision of this Agreement shall not be considered a waiver of their rights, either for that provision or any others.

If any part of this Agreement is found to be illegal, void, or unenforceable for any reason, the remaining provisions shall remain valid and enforceable.

### **28. AUTHORIZATION**

By electronically signing the Cruise Registration Form and/or the Shore Excursions Registration Form, the Cruise Participant agrees to the following:

"I authorize charges to be processed against my credit or debit card in the amount I indicated at the time of registration on the Cruise Registration Form and/or the Shore Excursions Registration Form. I fully agree to the terms and conditions outlined in this Cruise Participant Agreement.

"I understand that charges may be processed by 'Royal Caribbean' Cruise Line, 'Divine Revelation,' or both, and I authorize these charges to be made according to the payment schedule and rates specified on the Cruise Registration Form and/or the Shore Excursions Registration Form."

### 29. PERSONAL RESPONSIBILITY

By electronically signing the Cruise Registration Form, the Cruise Participant agrees to the following:

"I acknowledge that I am fully responsible for my own personal safety, health, and overall well-being (mentally, physically, emotionally, and otherwise) both during and after the Cruise.

"I hereby release the Cruise Presenters, Cruise Organizers, and their representatives, including employees, assistants, associates, affiliates, and contractors, from all liability for any injuries, damages, or losses I or any of my family members may experience during or after the Cruise.

"I understand that the Cruise is not psychotherapeutic or medical in nature and does not substitute for professional medical care. The Cruise does not provide treatment, diagnosis, or cures for any disease, illness, or disorder. Neither the Cruise Organizers nor the Cruise Presenters offer medical or psychological advice, nor do they prescribe or treat physical or mental health conditions.

"I understand that any private sessions, services, lectures, panels, workshops, Q&A sessions, recommendations, or suggestions offered during the Cruise are provided for educational and informational purposes only, and I accept them at my own discretion and risk.

"I acknowledge that the Cruise Organizers and Cruise Presenters assume no responsibility for the content or outcome of any services, activities, advice, or responses I may receive during the Cruise.

"I also release the Cruise Organizers, Cruise Presenters, and their respective representatives from any obligation to fulfill claims, whether spoken or written, or in audio or video format that may have appeared in promotional materials, emails, websites, social media, or any other form of communication related to the Cruise.

"I hold the Cruise Organizers and Cruise Presenters harmless for anything that may happen to me, my belongings, or my baggage (whether lost, stolen, or damaged) during the Cruise or as a result of participating in the Cruise.

"I further acknowledge that no health or travel insurance is provided by the Cruise Organizers, and that if I wish to be insured, I am solely responsible for arranging that coverage independently.

"I have read, understood, and agree to the terms set forth in this Cruise Participant Agreement."

## **30. HEALTH AGREEMENT**

By electronically signing the Cruise Registration Form, the Cruise Participant agrees to comply with all health-related restrictions, protocols, and mandates in effect at the time of sailing, as required by Royal Caribbean Cruise Line and/or the Cruise Organizers.

#### **31. RELEASE**

By electronically signing the Cruise Registration Form, the Cruise Participant fully releases the Cruise Presenters, Cruise Organizers, and their representatives from all responsibility and liability related to participation in the Cruise.
